## 2, Reasons

THK's dividend policy places importance on stable and continuous distribution based on mid-term operating results that reflects the changes in external operating environment. In accordance with this policy, THK sets its payout ratio on a consolidated basis at 30% and a minimum dividend for a fiscal year at ¥15.00 per share (¥7.5 per share for both interim dividend and year-end dividend).

Since THK celebrated its 50th anniversary of its founding on April 10, 2021, THK plans to add commemorative dividends of ¥5.00 per share (¥2.50 per share for interim dividend and year-end dividend each) to the dividend determined based on the payout ratio at 30% for the year ended December 31, 2021. In accordance with this plan, THK has decided to pay the year-end dividend of ¥39.50 per share (ordinary dividend of ¥37.00 per share and commemorative dividend of ¥2.50 per share). As a result, with the interim dividend of ¥20.50 per share, the amount of dividends for the year ended December 31, 2021 will be ¥60.00 per share.
