AEON CO., LTD. (the 'Company') hereby announces that we have recorded the following extraordinary losses (impairment losses) for the fourth quarter of the fiscal year ending February 28, 2026 (December 1, 2025 to February 28, 2026).

1. Extraordinary losses (impairment losses) and their details

In the fourth quarter of the fiscal year ending February 28, 2026 (December 1, 2025 to February 28, 2026), the Group recognized an impairment loss of 75,957 million yen for a portion of fixed assets related to stores and other facilities owned by the Group based on the Accounting Standard for Impairment of Fixed Assets.
